**PERSONAL GUARANTY AGREEMENT TO CREGGER COMPANY, INC.**

The undersigned acknowledge themselves fully bound by all provisions and statements contained in the foregoing Credit Agreement and hereby jointly and severally guarantee the payment, when due, to Cregger Company, Inc., or its successor in interest, of all amounts from time to time due and owing on the account named above, and the payment upon demand, of the entire amount due and owing on said account in the event of default in payment by the account debtor named above. This obligation and liability on the part of the undersigned shall be a primary and not a secondary obligation and liability, payable immediately upon demand, without Cregger Company, Inc. having to first seek recourse against any account or primary debtor and without first having to seek relief against collateral securing said account. The undersigned waive notice of acceptance, default, and demand for payment. The undersigned further acknowledge themselves bound to the payment of all late or finance charges assessed against said account at the rate of 2.0% per month (24% per annum), both before and after judgement is rendered and all costs of collection, including reasonable attorney's fees, in the event said account or this guaranty is placed with an attorney for enforcement of collection.

This Guaranty shall be a continuing and irrevocable guaranty and indemnity for indebtedness of the Applicant. The Guarantor hereby agrees, to the extent permitted by law, to waive the Homestead exemption, notice of acceptance, notice of presentment, demand, non-payment, dishonor and protest, along with the right to require Seller to proceed against the Applicant. This Personal Guaranty will remain in force for ten (10) years from date of last sale. Guarantor may revoke this Personal Guaranty only by providing Seller's Credit Manager written notice via certified mail of its intent to revoke. Revocation shall not relieve Guarantor of obligations incurred prior to receipt of such notice subject to the limit set forth above. Subsequent agreements and credit applications shall not serve to alter, supersede or otherwise modify this Personal Guaranty.
